The Workforce Innovation and Opportunity Act (WIOA) requires that services for individuals with disabilities be improved by increasing access to high-quality workforce services that prepare individuals with disabilities for competitive, integrated employment.

Under WIOA, workforce centers must provide physical and programmatic accessibility to employment and training services for individuals with disabilities. This Technical Assistance (TA) Bulletin provides Local Workforce Development Boards with resources to assist in meeting this requirement.

People-first language is used to speak appropriately and respectfully about an individual with a disability. People-first language emphasizes the individual first, not the disability.

Common Tools

There are many assistive technologies available for individuals with disabilities. Vendors usually offer training for their products. Below are some examples of popular AT products:

- [JAWS and MAGic](#)

Freedom Scientific makes video magnifiers, braille displays, screen-magnification software, and the screen reader JAWS (Job Access with Speech). These products provide access to print and computers for individuals with blindness, low vision, and/or learning disabilities.

- [ZoomText](#)
Ai Squared makes ZoomText, a magnification and reading program for Windows, tailored for low-vision users. ZoomText enlarges and enhances everything on the computer screen, echoes typing and essential program activity, and automatically reads documents, web pages, and e-mail.
- [UbiDuo](#)
sComm's UbiDuo products facilitate face-to-face communication among deaf, hard-of-hearing, late-deafened, and hearing individuals.
- [Sorenson Video Relay Service \(SVRS\)](#)
SVRS is a provider of VRS and videophones for individuals with hearing impairments.

This is a basic, hands-on course that includes demonstrations of AT and teaches students how to produce documents that comply with TWC Electronic and Information Resources (EIR) Accessibility Policy, state and federal accessibility laws and rules, and accessibility best practices.
