- Internet Access – Users should connect to this system using a dedicated broadband or high-speed access, 380k or higher. Users accessing the Internet through a cable modem or DSL meet this requirement.
 - Cookies – Users will need to enable the acceptance of cookies in their browser preferences. If they are unsure what cookies are or what they can do to enhance their browsing experience, click here to learn about cookies from Microsoft.
 - JavaScript – The selected browser must support JavaScript.
 - Pop-up Blockers – If users employ a Pop-Up Blocker, they will need to disable it in order to access certain features of the WIT Replacement Project system. Most Pop-Up Blockers can be disabled temporarily by holding down the CTRL key.

About the CMS Training Content

The Work in Texas system provides a robust list of reports and report categories to assist with all types of system reports. Report categories are organized in a logical manner so that users can locate pertinent reports with relative ease. Report outcomes are organized to provide an extensive amount of information based on data input.

To learn more about the report categories and the report titles available, refer to the Reports Training Guide.

Note: Reports will only generate data if specific program processes and functionality have occurred. For example, staff must have entered data throughout the program case management process that corresponds to the specific report parameters. As the Training environment is generally lighter on data compared to the Live site environment, you will want to either create data corresponding to the reports you want to show or validate prior to training that your search parameters will show meaningful results.

Getting Started: Staff Login

To manage report generation in the WIT system Training environment, staff must first log in to the training system, just as they would to manage service delivery for individuals in any of the programs that WIT includes.

Training participants will be using training accounts set up for Go Live training. Their initial login to the system may be problematic,

so allow for extra time to make sure everyone has logged in successfully. It is better to validate this early than to wait.

What you should know:

- Usernames are not case sensitive
- Passwords are case sensitive
- Multiple unsuccessful attempts can lock the user out of the system, based on security settings that might be in place. If this happens, authorized staff should be available to access the WIT Admin system to unlock staff training participants.

Reports Overview

The Virtual OneStop system includes a robust reporting module that lets users generate a wide variety of reports (as allowed by their assigned user privileges). Users can create reports that display:

- Information about the individuals and employers using the system and the methods they use to access information in the system.
- Information on services that are provided to these users.
- Statistical information on case management programs, job orders, job applicants, and résumé.
- Case management data related to goals, program applications, enrollments, skill attainment rates, program exits, and other information that reflects details of program workflows managed by staff/case managers.

Case management reports are the biggest and most helpful reporting category. These reports help staff members manage and quantify their workload, identify cases that require follow-up activities, and estimate performance in local regions before generating similar information that is required by federal reports. Beyond the introductory training exercises to acquaint training participants with the Reports design scheme, most of your time spent generating sample reports will occur within the Case Management reports category.

Note: The Live Data reports category is not available in the Work in Texas (WIT) system. Additionally, the State of Texas will not rely on federal reports available in the system. Rather, the State will continue to use its Data Warehouse utility to meet federal reporting requirements.

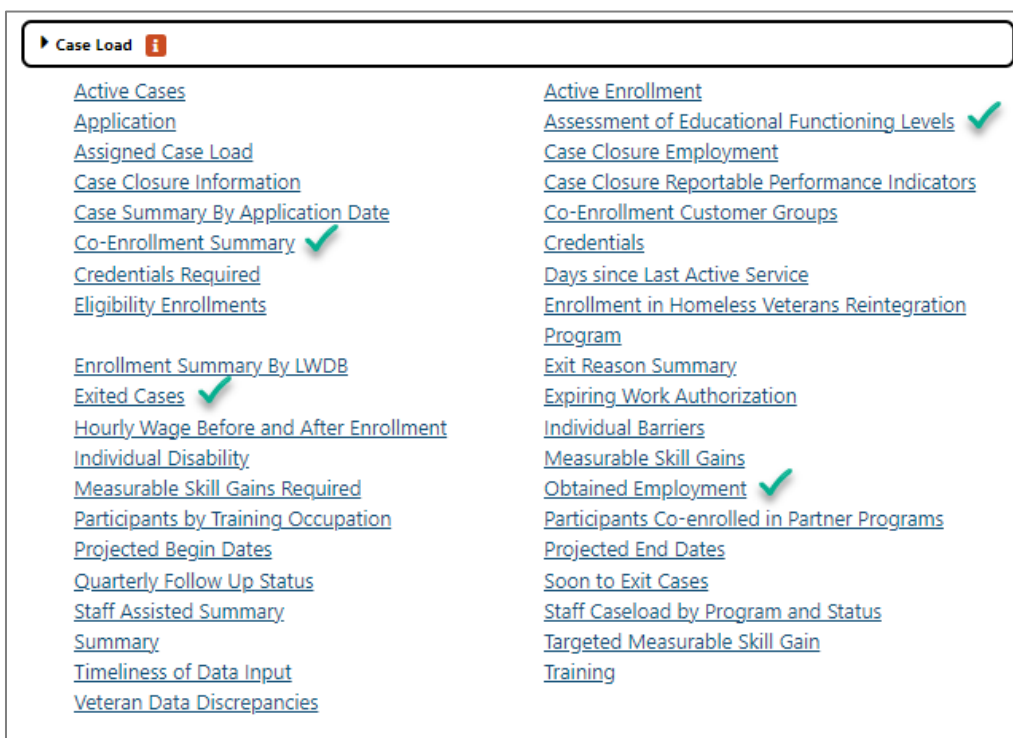

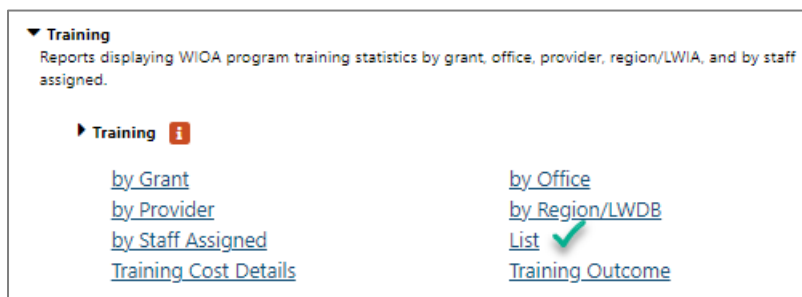
