Board Contract Year 2025 Texas Rising Star Mentor Distribution and Board CCQ Convening Discussion Paper

1 Background

- 2 The Texas Workforce Commission's (TWC) three-member Commission (Commission) provides
- 3 funding each year to the Local Workforce Development Boards to support Texas Rising Star Mentors.
- 4 TWC's financial support for Texas Rising Star Mentors has been increasing over the past few years,
- 5 based upon <u>Texas Government Code 2308.3155</u> which makes participation in the Texas Rising Star
- program a requirement for all child care programs participating in TWC's Child Care Services (CCS)
 program.

9 Issue 1 – Texas Rising Star Mentor Distribution for BCY'25

10 The Texas Government Code requires Boards to provide mentoring assistance to all CCS child care

- 11 programs, both to assist those who are not yet certified, and to assist those who are certified to pursue
- 12 higher star-levels. TWC estimated the costs associated with increasing mentoring services, as
- 13 published in the <u>HB2607 Fiscal Note</u>. Based upon the prior Fiscal Note, TWC staff estimated the
- 14 following amounts were needed to support Texas Rising Star mentors:

 16 BCY'23 \$22,000,000
 17 BCY'24 \$27,000,000
 18 BCY'25 \$29,000,000
- 19 BCY'26 \$31,000,000

Prior to BCY'23, the Texas Rising Star distribution methodology was more heavily weighted based on
the relative percent of each Board's Texas Rising Star programs. As Boards are now required to
support not only current Texas Rising Star-certified child care programs, but also support non-Texas

24 Rising Star child care programs, beginning in BCY'23, the distribution methodology considered a

- Board's relative percentage of all CCS child care programs (excluding relatives, military, and out-of state providers).

Because mentors are required to observe all classrooms within a child care program, also beginning in
 BCY'23 the distribution methodology considered the licensed capacity of providers, as this is a proxy
 for child care program/classroom size.

32 In BCY'23, the distribution methodology excluded CCS child care programs who have not had a CCS

- 33 child referred in the past 18 months as we expected that these providers may not continue their
- 34 participation in the CCS program given the requirement that they pursue Texas Rising Star
- 35 certification. In the past year, Boards have worked with all CCS providers to update their Provider
- Agreements and ensure that all providers understand their requirements regarding mandatory
 participation in Texas Rising Star. For the BCY'25 Mentor distribution, staff recommends including
- all providers with CCS agreements (excluding relatives, military, and out-of-state providers), as
- 39 Boards will be supporting all of these providers, regardless of whether they have active CCS referrals.

- For BCY'25, staff recommends Texas Rising Star Mentor distribution methodology include a
 \$150,000 base amount, and the following distribution criteria¹ for the remaining amount:
 - 60% based on the Board's relative proportion of all CCS child care programs
 - 40% based on the Board's relative proportion of licensed capacity of all CCS child care programs
- Additionally, staff recommends increasing the planned \$29 million distribution by \$62,000 to ensure
 all Boards are funded at least at the level they were in BCY'24.
- 10 Issue 2 Board Strategic Planning for Quality Improvement Convening
- 11 On February 28, 2023, the Commission <u>approved</u> the use of \$150,000 in federal child care stimulus
- 12 funds to support a statewide convening of Boards to provide training/technical assistance to support
- 13 their Boards in planning for the use of their Child Care Quality (CCQ) improvement funding. Child
- 14 Care & Early Learning (CC&EL) hosted this event October 3-4, 2023. The event was focused on
- 15 assisting the Boards in planning for the use of their BCY'24 CCQ funding.

- 17 CC&EL would like to host a Board Strategic Planning for Quality Improvement convening in August
- 18 2024, to assist the Boards in planning for the use of the BCY'24 CCQ funding. Staff recommends that
- 19 the Commission approve \$150,000 to support this effort. Funding will be used to support the costs of
- 20 the convening, including supporting Board travel, as outlined in Attachment 2.

21 **Decision Point**

- 22 Staff recommends that the Commission
- Increase the distribution for Texas Rising Star Mentors by \$66,665 and distribute \$29,066,665
 to Boards using the methodology as outlined above (Attachment 1); and
 - approve \$150,000 for a Board Strategic Planning for Quality Improvement convening in August 2024, as outlined above (Attachment 2).

¹ CCS Child Care providers who have an incorrect Child Care Regulation permit number were excluded from the calculation unless they had CCS children in care as of April 15, 2024. Prior to exclusion, CC&EL requested that Boards review and correct these providers' permit numbers in TWIST.
