“Fair Housing Initiatives Programs” (FHIPs) assist people who believe they have been victims of housing discrimination by serving as advocates, by filing housing discrimination complaints on behalf of individuals and for the FHIP organization, conducting preliminary investigation of claims, including sending "testers" to properties suspected of practicing housing discrimination, providing training to the public and housing professionals, and having initiatives that promote fair housing laws and equal housing opportunity awareness.
