

1 **CHAPTER 805. ADULT EDUCATION AND LITERACY**

2
3 **PROPOSED RULES TO BE PUBLISHED IN THE *TEXAS REGISTER*. THIS**
4 **DOCUMENT WILL HAVE NO SUBSTANTIVE CHANGES BUT IS SUBJECT TO**
5 **FORMATTING CHANGES AS REQUIRED BY THE OFFICE OF SECRETARY OF**
6 **STATE.**

7
8 The Texas Workforce Commission (TWC) proposes amendments to the following section of
9 Chapter 805, relating to Adult Education and Literacy:

10
11 Subchapter C. Service Delivery Structure and Alignment, §805.41

12
13 **PART I. PURPOSE, BACKGROUND, AND AUTHORITY**

14 The purpose of the proposed Chapter 805 amendments is to align the rules with federal statutory
15 language related to the state's requirement to award multiyear grants on a competitive basis to
16 eligible providers with demonstrated effectiveness within the state.

18 **PART II. EXPLANATION OF INDIVIDUAL PROVISIONS**

19
20 **SUBCHAPTER C. SERVICE DELIVERY STRUCTURE AND ALIGNMENT**

21 TWC proposes the following amendments to Subchapter C:

22
23 **§805.41. Procurement and Contracting**

24 Section 805.41(c) outlines the grant duration and term limits, which currently are more
25 restrictive than federal statutory language. TWC seeks to align rule language to statutory
26 language, which creates greater flexibility on defining grant duration.

27
28 **PART III. IMPACT STATEMENTS**

29 Chris Nelson, Chief Financial Officer, has determined that for each year of the first five years the
30 rules will be in effect, the following statements will apply:

31
32 There are no additional estimated costs to the state and to local governments expected as a result
33 of enforcing or administering the rules.

34
35 There are no estimated cost reductions to the state and to local governments as a result of
36 enforcing or administering the rules.

37
38 There are no estimated losses or increases in revenue to the state or to local governments as a
39 result of enforcing or administering the rules.

40
41 There are no foreseeable implications relating to costs or revenue of the state or local
42 governments as a result of enforcing or administering the rules.

43
44 There are no anticipated economic costs to individuals required to comply with the rules.
45

1 There is no anticipated adverse economic impact on small businesses, microbusinesses, or rural
2 communities as a result of enforcing or administering the rules.

3
4 Based on the analyses required by Texas Government Code, §2001.024, TWC has determined
5 that the requirement to repeal or amend a rule, as required by Texas Government Code,
6 §2001.0045, does not apply to this rulemaking.

7 8 Takings Impact Assessment

9 Under Texas Government Code §2007.002(5), "taking" means a governmental action that affects
10 private real property, in whole or in part or temporarily or permanently, in a manner that requires
11 the governmental entity to compensate the private real property owner as provided by the Fifth
12 and Fourteenth Amendments to the US Constitution or the Texas Constitution, §17 or §19,
13 Article I, or restricts or limits the owner's right to the property that would otherwise exist in the
14 absence of the governmental action, and is the producing cause of a reduction of at least 25
15 percent in the market value of the affected private real property, determined by comparing the
16 market value of the property as if the governmental action is not in effect and the market value of
17 the property determined as if the governmental action is in effect. TWC completed a Takings
18 Impact Analysis for the proposed rulemaking action under Texas Government Code §2007.043.
19 The primary purpose of this proposed rulemaking action, as discussed elsewhere in this
20 preamble, is to amend rules to implement changes related to the interpretation of federal statute
21 and regulations regarding procurement of Workforce Innovation and Opportunity Act (WIOA),
22 Title II funds.

23
24 The proposed rulemaking action will not create any additional burden on private real property or
25 affect private real property in a manner that would require compensation to private real property
26 owners under the US Constitution or the Texas Constitution. The proposal also will not affect
27 private real property in a manner that restricts or limits an owner's right to the property that
28 would otherwise exist in the absence of the governmental action. Therefore, the proposed
29 rulemaking will not cause a taking under Texas Government Code Chapter 2007.

30 31 Government Growth Impact Statement

32 TWC has determined that during the first five years the rules will be in effect, they:

- 33 --will not create or eliminate a government program;
- 34 --will not require the creation or elimination of employee positions;
- 35 --will not require an increase or decrease in future legislative appropriations to TWC;
- 36 --will not require an increase or decrease in fees paid to TWC;
- 37 --will not create a new regulation;
- 38 --will not expand, limit, or eliminate an existing regulation;
- 39 --will not change the number of individuals subject to the rules; and
- 40 --will not positively or adversely affect the state's economy.

41 42 Economic Impact Statement and Regulatory Flexibility Analysis

43 TWC has determined that the rules will not have an adverse economic impact on small
44 businesses or rural communities, as the proposed rules place no requirements on small businesses
45 or rural communities.

1 Mariana Vega, Director, Labor Market Information, has determined that there is not a significant
2 negative impact upon employment conditions in the state as a result of the rules.

3
4 Courtney Arbour, Director, Workforce Development Division, has determined that for each year
5 of the first five years the rules are in effect, the public benefit anticipated as a result of enforcing
6 the proposed rules will be to create greater flexibility in the length of grant awards to ensure
7 TWC can effectively develop, implement, and improve adult education and literacy services and
8 programs within the state.

9
10 TWC hereby certifies that the proposal has been reviewed by legal counsel and found to be
11 within TWC's legal authority to adopt.

12
13 **PART IV. COORDINATION ACTIVITIES**

14 The proposed amendments align TWC rules with federal statutes and regulations regarding
15 procurement of WIOA Title II funds. Adult Education and Literacy (AEL) program staff have
16 informed AEL grant recipients of the proposed rulemaking through their regular biweekly
17 conference calls. The public will have an opportunity to comment on these proposed rules for 30
18 days upon publication in the *Texas Register*.

20 **PART V. PUBLIC COMMENTS**

24 **PART VI. STATUTORY AUTHORITY**

25 The rules are proposed under Texas Labor Code, §301.0015 and §302.002(d), which provide
26 TWC with the authority to adopt, amend, or repeal such rules as it deems necessary for the
27 effective administration of TWC services and activities.

28
29 The proposed rules affect Title 4, Texas Labor Code, particularly Chapter 315.

3 **SUBCHAPTER C. SERVICE DELIVERY STRUCTURE AND ALIGNMENT**

5 **§805.41. Procurement and Contracting.**

- 6
7 (a) Eligible grant recipients shall compete for funding through a statewide procurement
8 process conducted in accordance with federal and state procurement requirements.
9 AEL funding shall be allocated as set forth in §800.68 and §800.69 of this title.
10
11 (b) Eligible grant recipients shall apply directly to the Agency using the grant solicitation
12 process, and shall meet all deadlines, requirements, and guidelines set forth in the
13 grant solicitation.
14
15 (c) Contracts awarded to AEL grant recipients shall be multiyear, at the Commission's
16 discretion. In considering a renewal, the Commission shall take into account
17 performance and other factors.
18
19 (1) Renewals for years three and beyond are not automatic and are based on
20 meeting or exceeding performance and expenditure benchmarks, or other
21 factors as determined by the Commission.
22
23 (2) The Agency shall conduct a new competitive statewide procurement at its
24 discretion and when appropriate to ensure that providers can effectively
25 develop, implement, and improve AEL services and programs within the state.
26
27 (d) Determinations by the Agency in the statewide procurement process will be based on
28 the indicated ability of the eligible grant recipient to effectively perform all services
29 and activities needed to fully comply with contract performance requirements and all
30 contract terms and conditions and may be influenced by factors used to determine
31 the allocation of AEL funds or other objective data or criteria.
