Electronic Correspondence Sign-up	TWC pays benefits by U.S. Bank's ReliaCard (debit card), or by direct deposit into your personal checking or savings account. Unless you sign up for direct deposit, you will receive your benefits on the ReliaCard. If you signed up for direct deposit on a prior claim, TWC will use the checking or savings account information you previously provided. NOTIFY TWC IMMEDIATELY if your
Claim and Payment Status	checking or savings account information has changed since your prior claim. If you don't your benefit payment(s) may be delayed.

Work Search Log	If you were paid unemployment benefits last year, TWC will mail you a Form 1099-G showing the total benefits we paid you. TWC will mail 1099-Gs through the end of January. Beginning mid-January, you can get the amount that TWC paid you by selecting IRS
WorkInTexas.com	1099-G Information from Quick Links or by calling Tele-Serv at <u>1-800-558-8321</u> and selecting option 2. You do not need the 1099-G form to file your tax return, just the amount TWC paid you.
