### **PURPOSE:**

To provide Local Workforce Development Boards (Boards) with information and guidance on Texas Rising Star (TRS) Providers participation in the Texas Procurement and Support Services Cooperative Purchasing Program (State of Texas CO-OP) administered by the Texas Comptroller of Public Accounts (Comptroller), specifically, providing notification to:

- TRS Providers: and
- the Comptroller regarding eligible TRS Providers.

### **BACKGROUND:**

Senate Bill 400, enacted by the 82nd Texas Legislature, Regular Session (2011), amends Texas Government Code §2155.202 to grant TRS Providers authority to participate in the State of Texas CO-OP.

The State of Texas CO-OP provides volume purchasing power to authorized local government and assistance organizations. State of Texas CO-OP members can purchase goods and services through state term contracts, Texas Multiple Award Schedule contracts, and piggyback contracts, thereby satisfying competitive bidding requirements.

## **PROCEDURES:**

# **Notification to Texas Rising Star Providers**

Boards must notify TRS Providers of the following:

• Effective September 1, 2011, TRS Providers are eligible to apply for participation in the State of Texas CO-OP;

- TRS Providers are responsible for applying to the State of Texas CO-OP if they wish to participate in the program;
- Information regarding the State of Texas CO-OP and the application process is on the Comptroller's Website at http://www.window.state.tx.us/procurement/prog/coop/; and

# Notification to Texas Comptroller of Public Accounts regarding Eligible Texas Rising Star Providers

Boards must be aware of the following:

- Effective September 1, 2011, the Texas Workforce Commission will send the Comptroller a list of all TRS Providers eligible to participate in the State of Texas CO-OP; and
- Effective October 1, 2011, and every month thereafter, an updated list will be provided to the Comptroller identifying TRS Providers that either gained or lost TRS status in the previous month.

Boards also must ensure the accuracy of all TRS Provider data contained in the Child Care Service Delivery application and in TWIST, which will ensure the accuracy of the initial list provided to the Comptroller.
